1. gr.

22. gr. breytist þannig:

Liður 22.30 (4), sbr. reglugerð nr. 242/1994, orðist svo:

- (4) Takmörkun hljóðstyrks í eyrnahæð ökumanns dráttarvélar telst vera fullnægjandi ef ákvæði EBE tilskipunar nr. 77/311 með breytingum í tilskipun nr. 82/890 og ákvörðun nr. 96/627 eru uppfyllt.
