

## AUGLÝSING

**um innleiðingu á breytingum á framkvæmdarreglugerð (ESB) 2021/404 um skrár yfir þriðju lönd, yfirráðasvæði eða hluta þeirra þaðan sem heimilt er að flytja inn dýr, kímefni og afurðir úr dýraríkinu til Sambandsins í samræmi við reglugerð Evrópuþingsins og ráðsins (ESB) 2016/429.**

### 1. gr.

Eftirfarandi reglugerðir öðlast gildi hér á landi með reglugerð nr. 760/2025 um (57.) breytingu á reglugerð nr. 580/2021 um gildistöku framkvæmdarreglugerðar framkvæmdastjórnarinnar (ESB) 2021/404 um skrár yfir þriðju lönd, yfirráðasvæði eða hluta þeirra þaðan sem heimilt er að flytja inn dýr, kímefni og afurðir úr dýraríkinu til Sambandsins í samræmi við reglugerð Evrópuþingsins og ráðsins (ESB) 2016/429, sem birt er í B-deild Stjórnartíðinda:

1. Framkvæmdarreglugerð framkvæmdastjórnarinnar (ESB) 2025/1085 frá 22. maí 2025 um breytingu á V. og XIV. viðauka við framkvæmdarreglugerð (ESB) 2021/404 að því er varðar færslurnar fyrir Kanada, Breska konungsríkið og Bandaríkin í skránum yfir þriðju lönd, yfirráðasvæði eða svæði þeirra sem hafa heimild til að flytja inn sendingar af alifuglum, kímefnum úr alifuglum og nýju kjöti af alifuglum og veiðifuglum til Sambandsins. Reglugerðin er birt á ensku í fylgiskjali 1 með auglýsingu þessari.
2. Framkvæmdarreglugerð framkvæmdastjórnarinnar (ESB) 2025/1200 frá 12. júní 2025 um breytingu á V., XIII. og XIV. viðauka við framkvæmdarreglugerð (ESB) 2021/404 að því er varðar færslurnar fyrir Kanada, Esvatíní, Breska konungsríkið og Bandaríkin í skránum yfir þriðju lönd, yfirráðasvæði eða svæði þeirra sem hafa heimild til að flytja inn sendingar af alifuglum, kímefnum úr alifuglum, nýju kjöti af nautgripum, öldum og villtum hóf- og klaufdýrum sem eru veiðidýr og nýju kjöti af alifuglum og veiðifuglum til Sambandsins. Reglugerðin er birt á ensku í fylgiskjali 2 með auglýsingu þessari.

### 2. gr.

Auglýsing þessi er sett með stoð í 31. gr. a laga um matvæli, nr. 93/1995, 7. gr. laga um eftirlit með fóðri, áburði og sáðvöru, nr. 22/1994, og 29. gr. b laga um dýrasjúkdóma og varnir gegn þeim, nr. 25/1993.

Þetta er hér með gert almenningi kunnugt.

**Fylgiskjal 1.****COMMISSION IMPLEMENTING REGULATION (EU) 2025/1085****of 22 May 2025****amending Annexes V and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada, the United Kingdom and the United States in the lists of third countries, territories or zones thereof authorised for the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds****(Text with EEA relevance)**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') <sup>(1)</sup>, and in particular Articles 230(1) and 232(1) and (3) thereof.

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin must come from a third country or territory, or zone or compartment thereof, listed in accordance with Article 230(1) of that Regulation in order to enter the Union.
- (2) Commission Delegated Regulation (EU) 2020/692 <sup>(2)</sup> lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries or territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404 <sup>(3)</sup> lays down the lists of third countries, or territories, or zones thereof, from which the entry into the Union of the species and categories of animals, germinal products and products of animal origin falling within the scope of Delegated Regulation (EU) 2020/692 is permitted. Those lists and certain general rules concerning those lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) More particularly, Annexes V and XIV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, or territories, or zones thereof authorised for the entry into the Union, respectively, of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds.
- (5) Canada has notified the Commission of two new outbreaks of highly pathogenic avian influenza (HPAI) in poultry in the provinces of Manitoba and Prince Edward Island which were confirmed on 7 May 2025 and 15 May 2025, respectively, by laboratory analysis (RT-PCR).
- (6) The United States has notified the Commission of five new outbreaks of HPAI in poultry in the states of Florida, Illinois, New Jersey, North Dakota, and South Dakota which were confirmed between 2 May 2025 and 13 May 2025 by laboratory analysis (RT-PCR).

- (7) Following those recent outbreaks of HPAI, the veterinary authorities of Canada and the United States established restricted zones of at least 10 km around the affected establishments and implemented a stamping-out policy to control the presence of HPAI and limit the spread of that disease.
- (8) Canada and the United States have submitted information to the Commission on the epidemiological situation in their respective territories as well as on the measures taken to prevent the further spread of HPAI following those recent HPAI outbreaks.
- (9) That information has been evaluated by the Commission. In view of the animal health situation in the areas under restrictions established by the veterinary authorities of Canada and the United States, the entry into the Union of consignments, of poultry and germinal products of poultry, and of fresh meat of poultry and game birds from the areas concerned by the recent outbreaks should be suspended in order to protect the animal health status of the Union. Therefore, the entries for Canada and the United States in the tables set out in in Section B, Part 1 and in Part 2 of Annex V, and the table set out in Section B, Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404 should be amended accordingly.
- (10) In addition, Canada, the United Kingdom and the United States have provided updated information to the Commission in relation to the epidemiological situation in their territories as regards HPAI that gave rise to the suspension of the entry into the Union of consignments of poultry, germinal products of poultry, and fresh meat of poultry and game birds, as set out in Annexes V and XIV to Implementing Regulation (EU) 2021/404.
- (11) On 24 April 2025 and 1 May 2025, Canada submitted updated information on the epidemiological situation in relation to two outbreaks of HPAI in poultry in the provinces of Newfoundland and Labrador and Ontario, which were confirmed on 12 February 2025 and 28 February 2025, respectively, by laboratory analysis (RT-PCR).
- (12) On 14 May 2025 and 15 May 2025, the United Kingdom submitted updated information on the animal health situation and the measures it has taken in relation to eight outbreaks of HPAI in poultry in the counties of Devon (1), Durham (1), Hampshire (2), Norfolk (1), and North Yorkshire (3), England which were confirmed between 31 January 2025 and 4 April 2025 by laboratory analysis (RT-PCR).
- (13) On 13 May 2025, the United States submitted updated information on the animal health situation and the measures it has taken in relation to 61 outbreaks of HPAI in poultry in the states of Arkansas (3), California (8), Delaware (1), Illinois (2), Indiana (5), Iowa (3), Maryland (4), Mississippi (1), Missouri (15), Montana (1), New York (2), North Carolina (3), North Dakota (2), Ohio (4), Pennsylvania (6), and Virginia (1), which were confirmed between 12 November 2024 and 20 March 2025 by laboratory analysis (RT-PCR).
- (14) Canada, the United Kingdom and the United States informed the Commission that, following those outbreaks of HPAI, they implemented a stamping out policy in order to control and limit the spread of that disease, and also completed the requisite cleaning and disinfection following the implementation of the stamping out policy on the infected poultry establishments.
- (15) The Commission has evaluated the information submitted by Canada, the United Kingdom and the United States, and considers that they have provided appropriate guarantees that the animal health situation that has given rise to the suspension of the entry of consignments of poultry and germinal products of poultry, and fresh meat of poultry and game birds into the Union from the affected zones, as set out in Annexes V and XIV to Implementing Regulation (EU) 2021/404, no longer represents a threat to animal or public health in the Union, and that, consequently, the entry into the Union of those consignments from the affected zones of Canada, the United Kingdom and the United States, from which entry into the Union has been suspended, should be reauthorised. Therefore, the entries for those third countries in the tables set out in Section B, Part 1 and in Part 2 of Annex V, and the table set out in Section B, Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404 should be amended accordingly.

- (16) Taking into account the new HPAI outbreaks in Canada and the United States, and in order to avoid any unnecessary disruption in trade with Canada, the United Kingdom and the United States, the amendments to be made to Annexes V and XIV to Implementing Regulation (EU) 2021/404 by this Regulation should take effect as a matter of urgency.
- (17) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

*Article 1*

Annexes V and XIV to Implementing Regulation (EU) 2021/404 are amended in accordance with the Annex to this Regulation.

*Article 2*

This Regulation shall enter into force on the day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

**amending Annexes V, XIII and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada, Eswatini, the United Kingdom and the United States in the lists of third countries, territories or zones thereof authorised for the entry into the Union of consignments of poultry and germinal products of poultry, fresh meat of bovine animals, farmed and wild game ungulates and fresh meat of poultry and game birds**

**(Text with EEA relevance)**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') <sup>(1)</sup>, and in particular Articles 230(1) and 232(1) and (3) thereof,

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin must come from a third country or territory, or zone or compartment thereof, listed in accordance with Article 230(1) of that Regulation in order to enter the Union.
- (2) Commission Delegated Regulation (EU) 2020/692 <sup>(2)</sup> lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries or territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404 <sup>(3)</sup> lays down the lists of third countries, or territories, or zones thereof, from which the entry into the Union of the species and categories of animals, germinal products and products of animal origin falling within the scope of Delegated Regulation (EU) 2020/692 is permitted. Those lists and certain general rules concerning those lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) More particularly, Annexes V, XIII and XIV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, territories, or zones thereof authorised for the entry into the Union respectively of consignments of poultry and germinal products of poultry, of fresh meat of bovine animals, farmed and wild game ungulates, and of fresh meat of poultry and game birds.
- (5) On 20 May 2025 and 28 May 2025, Eswatini has notified the World Organisation for Animal Health (WOAH) of in total five outbreaks of foot and mouth disease (FMD) in bovine, ovine and caprine animals in the region of Shiselweni which were confirmed between 19 May 2025 and 28 May 2025 by laboratory analysis (RT-PCR and NSP-ELISA).

- (7) Due to the risk of the introduction of FMD into the Union linked with the entry of consignments of fresh meat of bovine animals, farmed and wild game ungulates from zones SZ-1 and SZ-2 in Eswatini, and in the absence of guarantees allowing for regionalisation of that third country, the entry into the Union of such consignments should no longer be authorised.
- (8) The entries for zones SZ-1 and SZ-2 in Eswatini in the list of third countries, territories, or zones thereof set out in the table in Part 1 of Annex XIII to Implementing Regulation (EU) 2021/404 should therefore be amended to take account of the current epidemiological situation in that third country.
- (9) In addition, on 28 May 2025 and 3 June 2025, the United States has notified the Commission of four new outbreaks of HPAI in poultry in the states of Arizona (3) and New Jersey (1) which were confirmed between 19 May 2025 and 30 May 2025 by laboratory analysis (RT-PCR).
- (10) Following those recent outbreaks of HPAI, the veterinary authorities of the United States established restricted zones of at least 10 km around the affected establishments and implemented a stamping-out policy to control the presence of HPAI and limit the spread of that disease.
- (11) The United States has also submitted further information to the Commission on the epidemiological situation in its territory, as well as on the measures taken to prevent the further spread of HPAI following those recent HPAI outbreaks.
- (12) That information has been evaluated by the Commission. In view of the animal health situation in the areas under restrictions established by the veterinary authority of the United States, the entry into the Union of consignments, of poultry and germinal products of poultry, and of fresh meat of poultry and game birds from the areas concerned by the recent outbreaks should be suspended in order to protect the animal health status of the Union. Therefore, the entries for the United States in the tables set out in Part 1 and in Part 2, Section B of Annex V, and the table set out in Part 1, Section B of Annex XIV to Implementing Regulation (EU) 2021/404 should be amended accordingly.
- (13) Furthermore, Canada and the United Kingdom have provided updated information to the Commission in relation to the epidemiological situation in their territories as regards HPAI that previously gave rise to the suspension of the entry into the Union of consignments of poultry, germinal products of poultry, and fresh meat of poultry and game birds, as set out in Annexes V and XIV to Implementing Regulation (EU) 2021/404.
- (14) On 1 May 2025 and 13 May 2025, Canada submitted updated information on the epidemiological situation in relation to two outbreaks of HPAI in poultry in the province of Ontario, which were confirmed on 13 March 2025 and 24 March 2025, by laboratory analysis (RT-PCR).
- (15) On 27 May 2025 and 2 June 2025, the United Kingdom submitted updated information on the animal health situation and the measures it has taken in relation to two outbreaks of HPAI in poultry in the counties of East Sussex and North Yorkshire, England which were confirmed on 17 January 2025 and 14 April 2025, respectively, by laboratory analysis (RT-PCR).
- (16) Canada and the United Kingdom informed the Commission that, following those outbreaks of HPAI, they implemented a stamping out policy in order to control and limit the spread of that disease, and also completed the requisite cleaning and disinfection following the implementation of the stamping out policy on the infected poultry establishments.

- (17) The Commission has evaluated the information submitted by Canada and the United Kingdom, and considers that they have provided appropriate guarantees that the animal health situation that has given rise to the suspension of the entry of consignments of poultry and germinal products of poultry, and fresh meat of poultry and game birds into the Union from the affected zones, as set out in Annexes V and XIV to Implementing Regulation (EU) 2021/404, no longer represents a threat to animal or public health in the Union, and that, consequently, the entry into the Union of those consignments from the affected zones of Canada and the United Kingdom, from which entry into the Union has been suspended, should be reauthorised. Therefore, the entries for those third countries in the tables set out in Part 1 and in Part 2, Section B of Annex V, and the table set out in Part 1, Section B of Annex XIV to Implementing Regulation (EU) 2021/404 should be amended accordingly.
- (18) Taking into account the recent outbreaks of FMD in Eswatini and the new HPAI outbreaks in the United States, and in order to avoid any unnecessary disruption in trade with Canada and the United Kingdom, the amendments to be made to Annexes V, XIII and XIV to Implementing Regulation (EU) 2021/404 by this Regulation should take effect as a matter of urgency.
- (19) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

*Article 1*

Annexes V, XIII and XIV to Implementing Regulation (EU) 2021/404 are amended in accordance with the Annex to this Regulation.

*Article 2*

This Regulation shall enter into force on the day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
