Reglugerðin er birt á ensku í fylgiskjali 1 með auglýsingu þessari.
- 2. Framkvæmdarreglugerð framkvæmdastjórnarinnar (ESB) 2025/2265 frá 5. nóvember 2025 um breytingu á V. og XIV. viðauka við framkvæmdarreglugerð (ESB) 2021/404 að því er varðar færslurnar fyrir Kanada, Breska konungsríkið og Bandaríkin í skránum yfir þriðju lönd, yfirráðasvæði eða svæði þeirra sem hafa heimild til að flytja inn sendingar af alifuglum, kímefnum úr alifuglum og nýju kjöti af alifuglum og veiðifuglum til Sambandsins. Reglugerðin er birt á ensku í fylgiskjali 2 með auglýsingu þessari.

COMMISSION IMPLEMENTING REGULATION (EU) 2025/2220

of 3 November 2025

amending Annex XVI to Implementing Regulation (EU) 2021/404 as regards the entry for North Macedonia in the list of third countries or territories or zones thereof authorised for the entry into the Union of consignments of casings

(Text with EEA relevance)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') ('), and in particular Article 230(1) thereof.

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin must come from a third country or territory, or zone or compartment thereof, listed in accordance with Article 230(1) of that Regulation in order to enter the Union.
- (2) Commission Delegated Regulation (EU) 2020/692 (*) lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries or territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404 (3) lays down the lists of third countries, or territories, or zones thereof, from which the entry into the Union of the particular species and categories of animals, germinal products and products of animal origin concerned is permitted. Those lists and certain general rules concerning those lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) Annex XVI to Implementing Regulation (EU) 2021/404 sets out the list of third countries, territories or zones thereof authorised for the entry into the Union of consignments of casings. North Macedonia requested to be included in this list and has meanwhile submitted to the Commission its response to a questionnaire concerning the entry into the Union of consignments of casings from that third country in terms of animal and public health. North Macedonia has also provided evidence and guarantees to the Commission to be included in that list. The Commission has assessed the legislation and organisation of the control system, including certification procedures, in North Macedonia and has concluded that they are in line with the Union's requirements and animal health conditions regarding casings. Annex XVI to Implementing Regulation (EU) 2021/404 should therefore be amended accordingly.
- (5) Implementing Regulation (EU) 2021/404 should therefore be amended accordingly.

Annex XVI to Implementing Regulation (EU) 2021/404 is amended in accordance with the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

COMMISSION IMPLEMENTING REGULATION (EU) 2025/2265

of 5 November 2025

amending Annexes V and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada, the United Kingdom and the United States in the lists of third countries, territories, or zones thereof authorised for the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds

(Text with EEA relevance)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') (1), and in particular Articles 230(1) and 232(1), point (b) and 232(3), point (b) thereof.

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin from third countries or territories must be allowed to enter the Union only if the third countries or territories concerned are listed in accordance with Article 230(1) of that Regulation.
- (2) Commission Delegated Regulation (EU) 2020/692 (²) lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries, territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404 (²) lays down the lists of third countries, territories, or zones thereof, from which the entry into the Union of the species and categories of animals, germinal products and products of animal origin, falling within the scope of Delegated Regulation (EU) 2020/692, is permitted. Those lists and certain general rules concerning those lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) More particularly, Annexes V and XIV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, territories, or zones thereof, authorised for the entry into the Union, respectively, of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds.
- (5) Canada has notified the Commission of nine new outbreaks of highly pathogenic avian influenza (HPAI) in poultry in the provinces of Alberta, British Columbia, Manitoba, Quebec, and Saskatchewan, which were confirmed between 13 October 2025 and 26 October 2025 by laboratory analysis (RT-PCR).

(6) The United Kingdom has notified the Commission of four new outbreaks of HPAI in poultry in the counties of Cumbria, North Yorkshire, and Suffolk, England, and in the county of Denbighshire, Wales, which were confirmed on 25 October 2025 and 26 October 2025 by laboratory analysis (RT-PCR).

- (7) The United States has notified the Commission of 17 new outbreaks of HPAI in poultry in the states of Georgia (1), Idaho (1), Indiana (6), Minnesota (4), and Pennsylvania (5), which were confirmed between 14 October 2025 and 24 October 2025 by laboratory analysis (RT-PCR).
- (8) Following those recent outbreaks of HPAI, the veterinary authorities of Canada, the United Kingdom, and the United States established restricted zones of at least 10 km around the affected establishments and implemented a stamping-out policy to control the presence of HPAI and limit the spread of that disease.
- (9) Canada, the United Kingdom, and the United States have submitted information to the Commission on the epidemiological situation on their respective territories and the measures taken to prevent the further spread of HPAI following those recent HPAI outbreaks.
- (10) That information has been evaluated by the Commission. In view of the animal health situation in the areas under restrictions established by the veterinary authorities of Canada, the United Kingdom, and the United States, the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds from the areas concerned by the outbreaks in those third countries should be suspended in order to protect the animal health status of the Union, taking into account the dates when the outbreaks were confirmed. Therefore, the entries for those third countries in the tables set out in Section B of Part 1 and in Part 2 of Annex V, and the table set out in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404 should be amended accordingly.
- (11) In addition, Canada and the United States have provided updated information to the Commission in relation to the epidemiological situation on their respective territories as regards earlier outbreaks of HPAI that gave rise to the suspension of the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds, as set out in the table in Section B of Part 1 of Annex V, and in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404.
- (12) On 7 October 2025, Canada submitted updated information on the animal health situation and the measures it has taken in relation to two outbreaks of HPAI in poultry in the province of Alberta, which were confirmed on 9 September 2025 by laboratory analysis (RT-PCR).
- (13) On 23 October 2025, the United States submitted updated information on the animal health situation and the measures it has taken in relation to seven outbreaks of HPAI in poultry in the states of North Dakota and South Dakota, which were confirmed between 28 August 2025 and 13 September 2025 by laboratory analysis (RT-PCR).
- (14) Canada and the United States have informed the Commission that, following those earlier outbreaks of HPAI, they have implemented a stamping out policy in order to control and limit the spread of that disease, and they have also completed the requisite cleaning and disinfection following the implementation of the stamping out policy in the infected poultry establishments.
- (15) The Commission has evaluated the information submitted by Canada and the United States and considers that they have provided appropriate guarantees that the animal health situation that had given rise to the suspension of the entry of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds into the Union from the affected zones, as set out in the table in Section B of Part 1 of Annex V, and in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404, no longer represents a threat to animal or public health in the Union, and that, consequently, the entry into the Union of those consignments from the affected zones of Canada and the United States, from which entry into the Union had been suspended, should be re-authorised. Therefore, the entries for Canada and the United States in those tables in those Annexes should be amended accordingly.

(16) Taking into account the new HPAI outbreaks in Canada, the United Kingdom, and the United States, and in order to avoid any unnecessary disruption in trade with Canada and the United States, the amendments to be made to Annexes V and XIV to Implementing Regulation (EU) 2021/404 by this Regulation should take effect as a matter of urgency.

(17) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

Article 1

Annexes V and XIV to Implementing Regulation (EU) 2021/404 are amended in accordance with the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the day following that of its publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
