Eftirfarandi reglugerðir öðlast gildi hér á landi með reglugerð nr. 704/2026 um (68.) breytingu á reglugerð nr. 580/2021 um gildistöku framkvæmdarreglugerðar framkvæmdastjórnarinnar (ESB) 2021/404 um skrár yfir þriðju lönd, yfirráðasvæði eða hluta þeirra þáðan sem heimilt er að flytja inn dýr, kímefni og afurðir úr dýraríkinu til Sambandsins í samræmi við reglugerð Evrópuþingsins og ráðsins (ESB) 2016/429, sem birt er í B-deild Stjórnartíðinda:

1. Framkvæmdarreglugerð framkvæmdastjórnarinnar (ESB) 2026/1207 frá 2. júní 2026 um breytingu á V. og XIV. viðauka við framkvæmdarreglugerð (ESB) 2021/404 að því er varðar færslurnar fyrir Kanada, Breska konungsríkið og Bandaríkin í skránum yfir þriðju lönd, yfirráðasvæði eða svæði þeirra sem hafa heimild til að flytja inn sendingar af alifuglum, kímefnum úr alifuglum og nýju kjöti af alifuglum og veiðifuglum til Sambandsins. Reglugerðin er birt á ensku í fylgiskjali 3 með auglýsingu þessari.

Fylgiskjal 1.**COMMISSION IMPLEMENTING REGULATION (EU) 2026/1140****of 20 May 2026****amending Annexes V and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada and the United States in the lists of third countries, territories, or zones thereof authorised for the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds****(Text with EEA relevance)**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law')⁽¹⁾, and in particular Article 230(1), Article 232(1), point (b) and Article 232(3), point (b) thereof,

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin from third countries or territories are only to be allowed to enter into the Union if the third countries or territories concerned are listed in accordance with Article 230(1) of that Regulation.
- (2) Commission Delegated Regulation (EU) 2020/692⁽²⁾ lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries, territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404⁽³⁾ lays down the lists of third countries, territories, or zones thereof, from which the entry into the Union of the species and categories of animals, germinal products and products of animal origin, falling within the scope of Delegated Regulation (EU) 2020/692, is permitted. Those lists and certain general rules concerning those lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) More particularly, Annexes V and XIV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, territories, or zones thereof, authorised for the entry into the Union, respectively, of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds.
- (5) On 14 May 2026, Canada has notified the Commission of two new outbreaks of highly pathogenic avian influenza (HPAI) in poultry in the province of Alberta, which were confirmed on 11 May 2026 by laboratory analysis (RT-PCR).
- (6) On 7 May 2026 and 14 May 2026, the United States has notified the Commission of a total of six new outbreaks of HPAI in poultry in the states of Indiana, Minnesota, and North Dakota, which were confirmed between 1 May 2026 and 12 May 2026 by laboratory analysis (RT-PCR).
- (7) Following those recent outbreaks of HPAI, the veterinary authorities of Canada and the United States notified the establishment of restricted zones of at least 10 km around the affected establishments and the implementation of a stamping-out policy to control the presence of HPAI and limit the spread of that disease.

- (8) Canada and the United States have submitted further information to the Commission on the epidemiological situation on their respective territories and the measures that were taken to prevent the further spread of HPAI following those recent HPAI outbreaks.
- (9) The information provided by Canada and the United States has been evaluated by the Commission. In view of the animal health situation in the areas under restrictions established by the veterinary authorities of Canada and the United States, it is appropriate to suspend the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds from the areas concerned by the new outbreaks in those third countries in order to protect the animal health status of the Union, taking into account the dates when the outbreaks were confirmed. Therefore, the entries for Canada and the United States in the tables set out in Section B of Part 1 and in Part 2 of Annex V, and the table set out in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404 should be amended accordingly.
- (10) In addition, the United States has provided updated information to the Commission in relation to the epidemiological situation on its territory as regards earlier outbreaks of HPAI that gave rise to the suspension of the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds, as set out in the table in Section B of Part 1 of Annex V, and in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404.
- (11) In particular, on 5 May 2026 and 14 May 2026, the United States submitted updated information on the animal health situation and the measures it had taken in relation to 50 outbreaks of HPAI in poultry in the states of California, Colorado, Indiana, Maryland, Minnesota, New Jersey, New York, North Dakota, Pennsylvania, Vermont, and Wisconsin, which were confirmed between 14 October 2025 and 1 April 2026 by laboratory analysis (RT-PCR).
- (12) The United States has informed the Commission that, following those earlier outbreaks of HPAI, it had implemented a stamping out policy in order to control and limit the spread of that disease, and it had also completed the requisite cleaning and disinfection following the implementation of the stamping out policy in the infected poultry establishments.
- (13) The Commission has evaluated the information submitted by the United States in that regard and considers that it has provided appropriate guarantees that the animal health situation that had given rise to the suspension of the entry of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds into the Union from the affected zones, as set out in the table in Section B of Part 1 of Annex V, and in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404, no longer represents a threat to animal or public health in the Union, and that, consequently, the entry into the Union of those consignments from the affected zones of the United States, from which entry into the Union had been suspended, should be re-authorised. Therefore, the entries for the United States in those tables in those Annexes should be amended accordingly.
- (14) Taking into account the new HPAI outbreaks in Canada and the United States, and in order to avoid any unnecessary disruption in trade with the United States, the amendments to be made to Annexes V and XIV to Implementing Regulation (EU) 2021/404 by this Regulation should take effect as a matter of urgency.
- (15) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

Article 1

Annexes V and XIV to Implementing Regulation (EU) 2021/404 are amended in accordance with the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law')⁽¹⁾, and in particular Article 230(1) and Article 232(3), point (b) thereof,

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin from third countries or territories are only to be allowed to enter into the Union if the third countries or territories concerned are listed in accordance with Article 230(1) of that Regulation.
- (2) Commission Delegated Regulation (EU) 2020/692⁽²⁾ lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries, territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404⁽³⁾ lays down the lists of third countries, territories, or zones thereof, from which the entry into the Union of the species and categories of animals, germinal products and products of animal origin, falling within the scope of Delegated Regulation (EU) 2020/692, is permitted. Those lists and certain general rules concerning those lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) More particularly, Annexes XIV and XV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, territories, or zones thereof, authorised for the entry into the Union, respectively, of consignments of fresh meat of poultry and game birds, and of meat products from ungulates, poultry and game birds.
- (5) Following an outbreak of highly pathogenic avian influenza (HPAI) in poultry in the municipality of Petrovo in Republika Srpska, in Bosnia and Herzegovina, which was confirmed on 25 February 2026, Commission Implementing Regulation (EU) 2026/520⁽⁴⁾ suspended the entry into the Union of consignments of fresh meat of

poultry from that country by amending, inter alia, the entries for that third country in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404. Implementing Regulation (EU) 2026/520 also included, in the entries for Bosnia and Herzegovina in the table in Section A of Part 1 of Annex XV to Implementing Regulation (EU) 2021/404, the requirement that consignments of meat products from poultry are only to be allowed entry into the Union if those meat products have undergone a specific risk-mitigating treatment 'D' in accordance with Annex XXVI to Delegated Regulation (EU) 2020/692.

- (6) On 6 April 2026, Bosnia and Herzegovina submitted updated information to the Commission on the epidemiological situation on its territory in relation to the outbreak of HPAI in poultry confirmed on 25 February 2026, and the measures it has taken to prevent the further spread of that disease. In particular, following that outbreak of HPAI, Bosnia and Herzegovina has implemented a stamping out policy to control and limit the spread of that disease, cleaning and disinfection following the implementation of the stamping out policy in the affected establishments, and a surveillance programme demonstrating the absence of infection in the populations at risk.
- (7) The Commission has evaluated the information submitted by Bosnia and Herzegovina and concluded that it has provided appropriate guarantees that the animal health situation that had given rise to the suspension of the entry into the Union of consignments of fresh meat of poultry, as set out in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404, no longer represents a threat to animal or public health in the Union, and that, consequently, the entry into the Union of those consignments from Bosnia and Herzegovina may be re-authorised. In addition, the entry into the Union of consignments of meat products from poultry from Bosnia and Herzegovina should be subject to an assigned non-specific treatment 'A', and this requirement should be set out in column 10 of the table in Part 1, Section A of Annex XV to Implementing Regulation (EU) 2021/404.
- (8) Annexes XIV and XV to Implementing Regulation (EU) 2021/404 should, therefore, be amended accordingly.
- (9) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law')⁽¹⁾, and in particular Article 230(1), Article 232(1), point (b) and Article 232(3), point (b) thereof,

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin from third countries or territories are only to be allowed to enter into the Union if the third countries or territories concerned are listed in accordance with Article 230(1) of that Regulation.
- (2) Commission Delegated Regulation (EU) 2020/692⁽²⁾ lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries, territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404⁽³⁾ lays down the lists of third countries, territories, or zones thereof, from which the entry into the Union of the species and categories of animals, germinal products and products of animal origin, falling within the scope of Delegated Regulation (EU) 2020/692, is permitted. Those lists and certain general rules concerning those lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) More particularly, Annexes V and XIV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, territories, or zones thereof, authorised for the entry into the Union, respectively, of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds.
- (5) On 21 May 2026 and 22 May 2026, Canada has notified the Commission of two new outbreaks of highly pathogenic avian influenza (HPAI) in poultry in the provinces of Saskatchewan and Alberta, which were confirmed on 12 May 2026 and 19 May 2026, respectively, by laboratory analysis (RT-PCR).
- (6) On 21 May 2026, the United States has notified the Commission of a total of six new outbreaks of HPAI in poultry in the states of Indiana and Minnesota, which were confirmed between 15 May 2026 and 20 May 2026 by laboratory analysis (RT-PCR).

- (7) Following those recent outbreaks of HPAI, the veterinary authorities of Canada and the United States notified the establishment of restricted zones of at least 10 km around the affected establishments and the implementation of a stamping-out policy to control the presence of HPAI and limit the spread of that disease.
- (8) Canada and the United States have submitted further information to the Commission on the epidemiological situation on their respective territories and the measures that were taken to prevent the further spread of HPAI following those recent HPAI outbreaks.
- (9) The information provided by Canada and the United States has been evaluated by the Commission. In view of the animal health situation in the areas under restrictions established by the veterinary authorities of Canada and the United States, it is appropriate to suspend the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds from the areas concerned by the new outbreaks in those third countries in order to protect the animal health status of the Union, taking into account the dates when the outbreaks were confirmed. Therefore, the entries for Canada and the United States in the tables set out in Section B of Part 1 and in Part 2 of Annex V, and the table set out in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404 should be amended accordingly.
- (10) In addition, the United Kingdom has provided updated information to the Commission in relation to the epidemiological situation on its territory as regards earlier outbreaks of HPAI that gave rise to the suspension of the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds, as set out in the table in Section B of Part 1 of Annex V, and in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404.
- (11) In particular, on 21 May 2026 and 28 May 2026, the United Kingdom submitted updated information on the animal health situation and the measures it had taken in relation to four outbreaks of HPAI in poultry in the counties of Cambridgeshire and Lincolnshire, in England, which were confirmed between 11 April 2026 and 17 April 2026 by laboratory analysis (RT-PCR).
- (12) The United Kingdom has informed the Commission that, following those earlier outbreaks of HPAI, it had implemented a stamping out policy in order to control and limit the spread of that disease, and it had also completed the requisite cleaning and disinfection following the implementation of the stamping out policy in the infected poultry establishments.
- (13) The Commission has evaluated the information submitted by the United Kingdom in that regard and considers that it has provided appropriate guarantees that the animal health situation that had given rise to the suspension of the entry of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds into the Union from the affected zones, as set out in the table in Section B of Part 1 of Annex V, and in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404, no longer represents a threat to animal or public health in the Union, and that, consequently, the entry into the Union of those consignments from the affected zones of the United Kingdom, from which entry into the Union had been suspended, should be re-authorised. Therefore, the entries for the United Kingdom in those tables in those Annexes should be amended accordingly.
- (14) Taking into account the new HPAI outbreaks in Canada and the United States, and in order to avoid any unnecessary disruption in trade with the United Kingdom, the amendments to be made to Annexes V and XIV to Implementing Regulation (EU) 2021/404 by this Regulation should take effect as a matter of urgency.
- (15) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,
