Eftirfarandi reglugerðir öðlast gildi hér á landi með reglugerð nr. 777/2026 um (69.) breytingu á reglugerð nr. 580/2021 um gildistöku framkvæmdarreglugerðar framkvæmdastjórnarinnar (ESB) 2021/404 um skrár yfir þriðju lönd, yfirráðasvæði eða hluta þeirra þaðan sem heimilt er að flytja inn dýr, kímefni og afurðir úr dýraríkinu til Sambandsins í samræmi við reglugerð Evrópuþingsins og ráðsins (ESB) 2016/429, sem birt er í B-deild Stjórnartíðinda:

1. Framkvæmdarreglugerð framkvæmdastjórnarinnar (ESB) 2026/1169 frá 1. júní 2026 um breytingu á VIII. viðauka við framkvæmdarreglugerð (ESB) 2021/404 að því er varðar færslurnar fyrir Montenegro (Svartfjallaland) og Serbíu í skránni yfir þriðju lönd eða yfirráðasvæði eða svæði þeirra sem hafa heimild til að flytja inn sendingar af hundum, köttum og frettum til Sambandsins. Reglugerðin er birt á ensku í fylgiskjali 1 með auglýsingu þessari.
2. Framkvæmdarreglugerð framkvæmdastjórnarinnar (ESB) 2026/1344 frá 11. júní 2026 um breytingu á V. og XIV. viðauka við framkvæmdarreglugerð (ESB) 2021/404 að því er varðar færslurnar fyrir Kanada, Chile (Síle) og Bandaríkin í skránum yfir þriðju lönd, yfirráðasvæði eða svæði þeirra sem hafa heimild til að flytja inn sendingar af alifuglum, kímefnum úr alifuglum og nýju kjöti af alifuglum og veiðifuglum til Sambandsins. Reglugerðin er birt á ensku í fylgiskjali 2 með auglýsingu þessari.

2. gr.

Auglýsing þessi er sett með stoð í 31. gr. a laga um matvæli, nr. 93/1995, 7. gr. laga um eftirlit með fóðri, áburði og sáðvöru, nr. 22/1994, og 29. gr. b laga um dýrasjúkdóma og varnir gegn þeim, nr. 25/1993.

Fylgiskjal 1.**COMMISSION IMPLEMENTING REGULATION (EU) 2026/1169****of 1 June 2026****amending Annex VIII to Implementing Regulation (EU) 2021/404 as regards the entries for Montenegro and Serbia in the list of third countries or territories, or zones thereof authorised for the entry into the Union of consignments of dogs, cats and ferrets****(Text with EEA relevance)**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') ⁽¹⁾, and in particular Article 230(1) thereof,

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin must come from a third country or territory, or zone or compartment thereof, listed in accordance with Article 230(1) of that Regulation in order to enter into the Union.
- (2) Commission Delegated Regulation (EU) 2020/692 ⁽²⁾ lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries or territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter into the Union. In particular, Article 76 of that Delegated Regulation sets out the specific requirements as regards consignments of dogs, cats and ferrets intended for entry into the Union, including in paragraph 1, point (b) of that Article, the rabies antibody titration test requirements for such animals.
- (3) Commission Implementing Regulation (EU) 2021/404 ⁽³⁾ lays down the lists of third countries or territories, or zones thereof, from which the entry into the Union of the particular species and categories of animals, germinal products and products of animal origin concerned is permitted. Those lists and certain general rules concerning those lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) The table in Part 1 of Annex VIII to Implementing Regulation (EU) 2021/404 sets out the list of third countries or territories, or zones thereof, authorised for the entry into the Union of consignments of dogs, cats and ferrets. Montenegro and Serbia appear in that list with an assigned specific condition, in column 5 of that table, 'rabies antibody titration test'. This requires dogs, cats and ferrets of any consignments from those third countries to have undergone a valid rabies antibody titration test in accordance with Article 76(1), point (b), of Delegated Regulation (EU) 2020/692 before entering into the Union. Montenegro and Serbia have now requested to be listed without that specific condition in column 5 of the table in Part 1 of Annex VIII to Implementing Regulation (EU) 2021/404, and they have provided sufficient evidence and guarantees to the Commission substantiating that request. Annex VIII to Implementing Regulation (EU) 2021/404 should, therefore, be amended accordingly.

- (5) Implementing Regulation (EU) 2021/404 should, therefore, be amended accordingly.
- (6) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

Article 1

Annex VIII to Implementing Regulation (EU) 2021/404 is amended in accordance with the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the seventh day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Fylgiskjal 2.**COMMISSION IMPLEMENTING REGULATION (EU) 2026/1344****of 11 June 2026****amending Annexes V and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada, Chile and the United States in the lists of third countries, territories, or zones thereof authorised for the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds****(Text with EEA relevance)**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') ⁽¹⁾, and in particular Article 230(1), Article 232(1), point (b) and Article 232(3), point (b) thereof,

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin from third countries or territories are only to be allowed to enter into the Union if the third countries or territories concerned are listed in accordance with Article 230(1) of that Regulation.
- (2) Commission Delegated Regulation (EU) 2020/692 ⁽²⁾ lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries, territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404 ⁽³⁾ lays down the lists of third countries, territories, or zones thereof, from which the entry into the Union of the species and categories of animals, germinal products and products of animal origin, falling within the scope of Delegated Regulation (EU) 2020/692, is permitted. Those lists and certain general rules concerning those lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) More particularly, Annexes V and XIV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, territories, or zones thereof, authorised for the entry into the Union, respectively, of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds.
- (5) On 29 May 2026 and 3 June 2026, the United States has notified the Commission of a total of eight new outbreaks of HPAI in poultry in the state of Indiana, which were confirmed between 20 May 2026 and 29 May 2026 by laboratory analysis (RT-PCR).
- (6) Following those recent outbreaks of HPAI, the veterinary authority of the United States notified the establishment of restricted zones of at least 10 km around the affected establishments and the implementation of a stamping-out policy to control the presence of HPAI and limit the spread of that disease.

- (7) The United States has submitted further information to the Commission on the epidemiological situation on its territory and the measures that were taken to prevent the further spread of HPAI following those recent HPAI outbreaks.
- (8) The information provided by the United States has been evaluated by the Commission. In view of the animal health situation in the areas under restrictions established by the veterinary authority of the United States, it is appropriate to suspend the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds from the areas concerned by the new outbreaks in that third country in order to protect the animal health status of the Union, taking into account the dates when the outbreaks were confirmed. Therefore, the entries for the United States in the tables set out in Section B of Part 1 and in Part 2 of Annex V, and the table set out in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404 should be amended accordingly.
- (9) In addition, Canada, Chile and the United States have provided updated information to the Commission in relation to the epidemiological situation on their respective territories as regards earlier outbreaks of HPAI that gave rise to the suspension of the entry into the Union of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds, as set out in the table in Section B of Part 1 of Annex V, and in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404.
- (10) In particular, on 14 May 2026 and 21 May 2026, Canada submitted updated information on the animal health situation and the measures it had taken in relation to two outbreaks of HPAI in poultry in the provinces of Alberta and Saskatchewan, which were confirmed on 24 November 2025 and 17 April 2026 by laboratory analysis (RT-PCR).
- (11) On 28 May 2026, Chile submitted updated information on the animal health situation and the measures it had taken in relation to an outbreak of HPAI in poultry in the Metropolitan Region, which was confirmed on 24 March 2026 by laboratory analysis (RT-PCR).
- (12) On 5 June 2026, the United States submitted updated information on the animal health situation and the measures it had taken in relation to 43 outbreaks of HPAI in poultry in the states of Delaware, Florida, Illinois, Indiana, Kansas, Maryland, Minnesota, South Carolina, South Dakota, Pennsylvania and Washington, which were confirmed between 12 December 2025 and 17 April 2026 by laboratory analysis (RT-PCR).
- (13) Canada, Chile and the United States have informed the Commission that, following those earlier outbreaks of HPAI, they had implemented a stamping out policy in order to control and limit the spread of that disease, and they had also completed the requisite cleaning and disinfection following the implementation of the stamping out policy in the infected poultry establishments.
- (14) The Commission has evaluated the information submitted by Canada, Chile and the United States in that regard and considers that they have provided appropriate guarantees that the animal health situation that had given rise to the suspension of the entry of consignments of poultry and germinal products of poultry, and of fresh meat of poultry and game birds into the Union from the affected zones, as set out in the table in Section B of Part 1 of Annex V, and in the table in Section B of Part 1 of Annex XIV to Implementing Regulation (EU) 2021/404, no longer represents a threat to animal or public health in the Union, and that, consequently, the entry into the Union of those consignments from the affected zones of Canada and Chile, from which entry into the Union had been suspended, should be re-authorised. Therefore, the entries for Canada and Chile in those tables in those Annexes should be amended accordingly.
- (15) Taking into account the new HPAI outbreaks the United States, and in order to avoid any unnecessary disruption in trade with Canada, Chile and the United States, the amendments to be made to Annexes V and XIV to Implementing Regulation (EU) 2021/404 by this Regulation should take effect as a matter of urgency.
- (16) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

Article 1

Annexes V and XIV to Implementing Regulation (EU) 2021/404 are amended in accordance with the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
